Resolution Committee Report

The Hood County Republican Convention was called into session following the Hood County Republican Precinct Convention on the morning of March 23, 2024. The Resolution Committee met during the County Convention to review, consider, and vote on the resolutions put forth by the Hood County Republican precincts.

The Resolution Committee was provided a folder from each precinct that was to contain minutes and any passed or failed resolutions that resulted from the various precinct convention meetings. Upon examining each folder, this committee discovered that a number of folders did not contain any resolutions or forms Exhibit E, which lists all passed resolutions, or forms Exhibit F, the list of all failed resolutions. Some folders contained resolutions but did not have Exhibits E or F. Because this committee could not determine if those resolutions passed or failed their precinct convention meeting, it was impossible to consider those resolutions.

In addition, a table with a sign that read *Resolution Committee* was placed in the main room of the convention. It was discovered that a stack of resolutions were placed on that table with no indication of whether or not the resolutions had been voted on by the precincts, if they passed or failed, or indeed the origins of the resolution. It was explained to this committee that some precinct chairs, attendees, and volunteers were unclear of the process of submitting the resolutions. Unfortunately, because there was no way to know if those resolutions were passed or not by their precincts or even if a precinct considered those resolutions, this committee was unable to consider them.

For the resolutions that were submitted with a completed Exhibit E, 26 were passed by unanimous vote and 14 resolutions were failed by this committee. A list of both are included in this report.

Resolution Calling for Judicial Reform of Publication and Accessibility of Findings of Fact

Be it resolved the Texas legislature require all courts to immediately validate and produce a mandatory Finding of Facts and Conclusions of Law for every substantive decision or final ruling in a case.

Be it further resolved that the Texas legislature require all courts to employ a certified shorthand reporter in all in-camera hearings, preserving the record in all transactions with the judge for any case and ensuring against technological manipulation of records or proceedings.

Be it further resolved that the Texas legislature require all judges to state their rationale for their final decision on the record.

Be it further resolved that the State Commission on Judicial Conduct shall henceforth be composed of 13 voting members either appointed by the Governor of the State of Texas or elected by the public and 1 member appointed by the Supreme Court, this latter member acting only in an advisory capacity.

Be it further resolved that the State requires the State Commission on Judicial Conduct shall henceforth make public all complaints, findings, and conclusions, and additionally justifying all such findings and conclusions of the Commission, publishing these each month in an online format that is accessible to the public.

Be it further resolved that the State requires the State Commission on Judicial Conduct shall increase its staff to levels to reflect the size of the Texas judiciary and maintain staffing levels to adequately address the number of complaints received on a yearly basis.
